**DUTIES AND RESPONSIBILITIES:**

Learns to access important information from well folders and lease folders, for example: lease agreements, lease flow charts, well location, etc. and becomes familiar with how to read maps using sections, township and ranges; uses quarter information to locate wells; learns to calculate oil sale run tickets using 6A 6B handbook; learns procedures followed by Bureau of Land Management (BLM) and the Navajo Nation (Nation) for Incidents of Noncompliance; becomes familiar with procedures of conducting oil and gas lease inspections; attends formal BLM training modules for certification.

Attends Fluid Minerals Inspection and Enforcement Production Courses; receives on the job training from certified BLM and Nation Inspectors; becomes familiar with gas meter calibration procedures and proving of Lease Automated Custody Transfer calibration procedures; learns entry level APD approval process; attains proficiency in lease site security requirements, oil field hazards, undesirable events, knowledge of oil field production equipment and associated facilities. Learns oil field safety requirements and attends H2S safety training annually.
