**DUTIES AND RESPONSIBILITIES:**

Plans, organizes, reviews and supervises the operations and activities of the Navajo Natural Heritage Program (NNHP). Prepares technical and non-technical reports and studies; makes presentations before Navajo Nation governmental agencies, the general public and outside agencies; may testify before governing and policy making bodies; formulates long and short term work plans and strategies for the NNHP; ensures program performance goals and objectives are met; prepares and monitors NNHP budgets; seeks additional funding from a variety of federal agencies; administers federal contracts and grants, administers Navajo Nation sub-contracts; ensures program compliance with BIA and other federal funding agencies and Navajo Nation program performance standards; participates in annual P.L. 93-638 Contract negotiations with the Bureau of Indian Affairs; coordinates with Navajo Nation entities in monitoring the P.L. 93-638 Contract. Plans, organizes, reviews and directs major research and management projects and monitors/reviews management and research data. Assigns, directs and review work of staff, evaluates employee's work performance, ensures compliance with established policies.

**QUALIFICATION REQUIREMENTS:**

**Education and Training:**

Bachelor's degree in Wildlife Management or related with at least thirty (30) semester hours in biological science; course-work must have included: at least nine (9) semester hours in wildlife subjects as mammalogy, ornithology, animal ecology, wildlife management or research courses in the field of wildlife biology or at least twelve (12) semester hours in zoology subjects as general zoology, invertebrate zoology, vertebrate zoology, comparative anatomy, physiology, genetics, ecology, cellular biology, parasitology, entomology, or research courses in such subjects; and at least nine (9) semester hours in botany or the related plant sciences; (excess courses in wildlife biology may be used to meet the zoology requirements where appropriate); **(to receive full credit for education/training, applicant must submit college transcripts, certificates, diploma, etc.)**

**Experience:**

Six (06) years of experience in wildlife management, zoology, botany or related natural resource management, two (2) years of which must have been in a supervisory or administrative position.

**Special Knowledge, Skills and Abilities:**
