**DUTIES AND RESPONSIBILITIES:**

**POSITION IS BUDGET AT 64 HOURS PER PAY PERIOD.**

Primary responsibility is to assist the elderly in boarding and departing from the Senior Center van. Assist the Cook to prepare hot meals in a special container for the home bound clients. Maintain vehicle in good sound and operating condition. Minor maintenance of the building. Inspect the Senior Center van on a daily basis, maintain ridership and mileage log of the vehicle. Submit required reports to the Senior Center Supervisor. Other assigned duties.

**QUALIFICATION REQUIREMENTS:**

**Education and Training:**

One (1) year of experience in driving a van, delivery van or light truck. Must have a clean driving record for the past five (5) years.

*(To receive full credit for education/training, applicant must submit copies of transcripts, certificates, degree, diploma, etc.)*

**Special Knowledge, Skills and Abilities:**

Bilingual and must be able to work under extreme pressure. Must be able to work overtime and on weekends. Must be able to read and write for minimal recording, requirements, speak the Navajo language fluently. Must be able to lift heavy bulk objects.

**License/Certification Requirements:**

Must possess a valid state driver's license. Within 90 days of date of hire, must obtain a Navajo Nation Vehicle Operator's Permit, a Cardiopulmonary Resuscitation (CPR) Certificate; a Criminal Background Check. Must pass a physical examination.

**Physical Requirements and Work Environments:**

Work requires lifting, moving carrying and transporting supplies weighing up to 25 pounds and assisting elders and disabled clients into and out of transport vehicle.
