DUTIES AND RESPONSIBILITIES:

Researching and implementing a server software that will enhance the technical application of permit documentation. Design, develop, maintain and enhance permit documentation database through internal computer systems. Developing new systems and programs as a programmer will be modified according to the programs goals. Developing project plans, including scoping, scheduling, and implementation for all system related projects. Researching, identifying, analyzing and meeting requirements of all internal and external end user applications. Provides technical assistance to internal staff; installs, tests and configures hardware/software applications. Plans and determines communication needs for new equipment installation; participates in the planning, implementation and installation of new systems and/or peripherals; coordinates major equipment repairs; conducts recurring user training on systems and software; develops and maintains the desktop/server/network systems recovery policies. Conduct research on emerging application development software products, languages, and standards in support of procurement and development efforts. Communicate with vendors for efficient implementation of new applications and/or systems for resolution of any adaptation issues. Evaluate, recommend, schedule, and perform software improvements and upgrades. Hands-on experience developing program test cases and plans. Consistently write, translate, and code software programs and applications according to specifications. Writing programming scripts to enhance functionality and/or performance of applications as necessary. Design, run and monitor software performance tests on new and existing programs for the purposes of correcting errors, isolating areas for improvement, and general debugging. Administer critical analysis of test results and deliver solutions to problematic areas. Generate statistics and written reports for management and/or team members on the status of the programming process. Maintaining the current five (5) departmental LANs, which includes three (3) WANs with three (3) federal agencies (U.S. DOI Office of Natural Resources Revenue, Bureau of Land Management, and Office of Surface Mining Reclamation & Enforcement). Duties include maintenance, repair, and monitoring of each network system, ensuring data and user security requirements are in full force, interacting with federal agency system personnel to determine compatibility of network infrastructure.
