**DUTIES AND RESPONSIBILITIES:**

Interview individuals and families and make home visits to obtain information on family dynamics and environment. Complete required assessment forms with families. Develop case plans with families utilizing assessment tools and social work and cultural knowledge. Monitor progress of family case plans, reassess and revise with individuals/families if necessary and maintain regular communication. Maintain a professional case file following policy and procedural guidelines. Prepare reports for family court and foster care review hearings, and other resource agencies. Attend court and provide testimony in court for court ordered home studies and on-going child welfare cases. Utilize and abide by the AlchiniBiBeehazAnii Act and other Navajo Nation laws or Acts. Attend the Foster Care Review Board hearings to report information on children. Coordinate and communicate with attorneys, law enforcement, and Federal Bureau of Investigation agents and other resources. Make placement of children for out of home care, monitor progress, medical, and educational needs of children in care and maintain monthly contacts. Worker to facilitate return of children. Provide advocacy as requested or needed. Plan, attend, and facilitate case staffing or consultations. Attend staff, MDT, CPT meetings, trainings, and participate in prevention activities.

**QUALIFICATION REQUIREMENTS: (Education, Experience and Training)**

**Minimum Qualifications:**

- A Bachelor's degree in Behavioral Health, Sociology, Social Work or related field; and two (2) years of case management or related experience; or an equivalent combination of education and experience.

**Special Requirements:**

- Possess a valid state driver's license.
- A favorable background investigation.
