DUTIES AND RESPONSIBILITIES:

Field work: Work in the field assisting Senior or Heavy Equipment Operators with road maintenance activities; assist with flag bearers /personnel safety control and guide traffic through road maintenance /construction activity areas, lead in setting up cones, flags, signs for safety control. Assure safety precautions for operator activity by observing, driving, walking and clearing maintenance road side areas; reporting back to operator for any problems /archeology sites, etc. Assist operator with miscellaneous maintenance repair on heavy equipment by using hand and power tools. Maintain fuel and oil logs, tire maintenance. Keep assigned vehicle /heavy equipment clean, etc. Keep daily job order records of field activities, mileage log. Maintains electronic & hard copy files for Navajo DOT road maintenance database. Ability to record and submission of field activities reports for each on-going projects for expenditures purposes and time frame of completion of each projects. Attend meeting, workshop, conferences and Division events, activities and other assignments should arise.

QUALIFICATION REQUIREMENTS:

Six (6) months of general road construction and maintenance experience.
