Maintain, IT security networks and troubleshoot all network issues IT environments. Monitor and test network performance and provide network performance statistics and reports. Recommend, schedule, and perform network improvements, upgrades, and repairs. Adhere to and complete project tasks within assigned timeframes. Support development and implementation of networking projects and new technology installations. Conduct research on network products, services, protocols, and standards in support of network procurement and development efforts. Evaluate and recommend for purchase networking hardware and software products. Write technical specifications for purchase of networking hardware and software products. Practice network asset management, including maintenance of network component inventory. Prepare and ensure accuracy of documentation, procedures manuals, and help sheets for network installations, including data, voice, and video systems.
