Under supervision, perform work of considerable difficulty, enforcing the Navajo Nation and federal mine safety laws and regulations' mine safety inspections of mining and sand & gravel operations, ability to provide mine safety training pursuant to the requirements of 30 CFR, Parts 46 and 48, conduct mine accidents investigation, provide recommendations to prevent mine accidents and improve the mine safety and health environment. Ability to communicate with mine and sand & gravel operations workers, management, federal and state governments, chapter officials and local residents on mine safety and health issues.

**QUALIFICATION REQUIREMENTS: (Education, Experience and Training)**

**Minimum Qualifications:**

- Two years of college education (48 college credit hours) in science or closely related field and four (4) years of mine safety experience.

**Preferred Qualifications:**

- Prior experience as a Mine Safety and Health Inspector with U.S. Mine Safety and Health Administration (MSHA).
- Posses MSHA Instructor Certificate.
- Certified to teach First Aid and issue First Aid Certificate.
