**DUTIES AND RESPONSIBILITIES:**

Plan, supervise and coordinate the dealing of a accounting recording, maintaining and providing of governmental accounting data related to Navajo Nation fiscal operations; Supervise Investment Section and monitor all Navajo Nation internal and external investments. Monitor financial conditions of selected institutions, analyze current position of investment portfolio and analyze ratio. Interact with Navajo Nation investment managers, custodian, consultants, banks, legal counsel, & the controller. Coordinate the Navajo Nation Investment Committee meetings (dates, agenda, presentations, minutes, appointments with presenters). on quarterly bases. Work with NNIC on investments issues per each meetings. Manage investment staff to maintain accurate internal ledgers, reporting, reconciled periodically the bank statements generated by Wells Fargo, Custodian, and etc. Participates in routine organizational and procedural analysis; performs special projects; serves as departmental coordinator or related committees and task forces; maybe delegated in the absence of the Controller. Coordinate annual Permanent Fund budget with the Controller, and attend budget hearing.

- A Bachelor's degree in Finance, Accounting, Business Administration, or closely related fields; and six (6) years of management work experience involving financial and accounting systems, budgets and fiscal policy analysis and information system; four (4) years of which must have been in a supervisory capacity.

- Licensed Certified Investment Management Analyst (CIMA), Certified Financial Planner (CEP) or successful completion of a Chartered Financial Analyst (CFA) Level 1 while maintaining a CFA Candidate status.
