Plans and develops grant proposals for community infrastructure development. Monitors Chapter projects to ensure proper requirements are met. Attends meetings to improve staff development & improve job performances. Safeguards and accounts for all assets including, but not limited to, funds and property for which there is a custodial responsibility. Complies with Navajo Nation, Federal, and State Laws & Policies.

QUALIFICATION REQUIREMENTS: (Education, Experience and Training)

Minimum Qualifications:

- A high school diploma/GED supplemented by college level courses in Business or related field; and three (3) years of experience working in public or business administration in the area of community or economic development; or an equivalent combination of education and experience.
