**DUTIES AND RESPONSIBILITIES:**

Performs the duties of a shift supervisor/Lead Correctional Officer ensuring and maintains order and protecting life and property. Supervises assigned shift personnel including shift briefings, reviews shift and daily activity reports, trains new Corrections Officer(s), monitors inmate case management system activities and programs through approved case plans, referrals and documentations, conducts performance appraisals, submits daily, weekly and monthly reports and statistics. Interact by inmate guidance and crisis intervention including monitoring inmate programs. Conducts booking, classifications, and releases of inmates including inventory personal belongings, Monitors inmate visitation, conducts inmate transportations and patrols cells. Prepares and serves meals for inmates, dispenses and supervises intake of medication prescribe by medical and maintains fire safety procedures, drills and protocols. Maintains proficiency with weapons and other related defense and control equipment, attends in-service training and meetings. May be delegated ion the absence of the Corrections Lieutenant.

**QUALIFICATION REQUIREMENTS: (Education, Experience and Training)**

**Minimum Qualifications:**

- A High School diploma or GED; and three (3) years or work experience as a Corrections/Detention Facility; or an equivalent combination of education and experience.

**Special Requirements:**

- A favorable background investigation; and no dishonorable military discharge
- Successful completion of drug screening, physical agility test and physical examination.
- Possess a BIA Basic Correction Officer Training Certificate, a Cardiopulmonary Resuscitation (CPR) Certificate, a First Aid Certificate, a valid State Driver's License.
