DUTIES AND RESPONSIBILITIES:

Inspect mining operations and reclamation, review of surface coal mining permit application packages (PAP); and review of mid-term review documents of the PAP. Conduct administrative review on surface mining operations, water quality, soil stabilization contour, vegetation, and environmental protection relative to Surface Mining Control and Reclamation Act of 1977, and its amendments (SMCRA), its regulations and the approval mining plans. Act as liaison between the U.S. Office of Surface Mining Reclamation & Enforcement (OSMRE) staff and the Navajo Nation Minerals Department. Coordinate with the U.S. Bureau of Indian Affairs (BIS), the U.S. Bureau of Land Management (BLM), other Federal and Tribal Agencies in monitoring surface disturbance and reclamation in the initiation of the long-range livestock and range management plans for the vegetated mining and reclamation operations on the Navajo Nation. Willing to travel extensively for inspections, trainings, and meetings.

QUALIFICATION REQUIREMENTS: (Education, Experience and Training)

Minimum Qualifications:

* A Bachelor's Degree in Science, Engineering, Environmental Science, Range Management, Biology, Geology, Hydrology or a closely-related field; and three (3) years of progressively responsible surface mining reclamation experience.

- * A Masters Degree in Science, Engineering, Environmental Science, Range Management, Biology, Geology, Hydrology or a closely-related field.
- * Two (2) years of surface coal mining experience.
