Investigate criminal acts such as sexual assaults, armed robberies, home invasions, and property crimes such as burglaries; Collect and use forensic evidence to solve crimes; Interview informants, suspects and witnesses; Collect physical evidence and send specimens to laboratory; Run fingerprints through database to obtain matches; Process crime scenes and follow up on leads; Prepare investigative reports; Prepare sketches and diagrams; Obtain search warrants; Perform surveillance and monitor suspects; Assist victims of crime; Coordinate investigative activities with other agencies; Work with prosecutors and testify in criminal court proceedings.
