DUTIES AND RESPONSIBILITIES:

- Must be available 24 hours/7 days/week, including callback or standby duty.
- Must be able to work different or rotating shifts.
- Must be able to travel and take assignments on moments notice on or off the Navajo Nation.
- Must perform these duties and responsibilities of the EMT One Classification as prescribed and in accordance with the principles and practices of emergency care while in the field.
- Assist in and around the Facility Emergency Room in accordance to Facility and Emergency Medical Service guidelines or protocols.
- Perform care and preventive maintenance over ambulance vehicles, replace or replenish supplies, materials or equipment.
- Must communicate effectively, orally and in written form.
- Must perform public education and awareness training or presentations to the public.

QUALIFICATION REQUIREMENTS:

Education and Training:

A high school diploma or GED.

Experience:

(to receive full credit for education/training, applicant must submit copies of college transcript, certificates, diploma, etc.)

Special Knowledge, Skills and Abilities:

Knowledge of basic first aid treatment; of basic medical terminology; skilled in operating a motor vehicle in emergency situations; ability to communicate in Navajo/English languages; lift heavy objectives; work rotation schedule; maintain emotional and mental stability in emergency situations; utilize quick and prudent judgment in emergency situations.

Special Requirements:

Must possess a valid state drivers license. Within 90 days of employment must obtain a Cardiopulmonary Resuscitation (CPR) Health Care Provider Certificate, a Navajo Nation Vehicle Operator's Permit, and must pass a physical examination. Within one (1) year of employment must obtain an EMT Basic License.
