**DUTIES AND RESPONSIBILITIES:**

Position will be required to promote prevention and awareness of methamphetamine and suicide to communities and chapter meetings. Position will be required to serve as a resource for referral information. Provide information on the services that the Navajo Treatment Center for Children and Their Families (NTCCF) program provides. Advocates on behalf of the services that the program provides. Develops and implements community resource on prevention and awareness of methamphetamine and suicide. Provides prevention education to schools, chapters, programs and departments on methamphetamine and suicide. Position will provide intake on clients at seven (07) clinics. Positions will be required to screen clients to determine level of services needed or required. Provides assessment and develops a treatment plan for the client to receive therapeutic services by a licensed clinical provider. Performs crisis intervention. Provides case management activities. Monitors progress through accurate and complete progress notes. Develops and implements conditions of grant award to local schools, departments and programs to emphasize prevention and awareness of methamphetamine and suicide. Attends meetings and sessions on methamphetamine and suicide. Conducts meetings with schools and chapters. Meets with chapter officials and planning committees in reference to the community needs in the area of methamphetamine and suicide. Work closely with mental health providers on the therapeutic services that the program provides to Navajo children and their families. Attends staff meetings.

**QUALIFICATION REQUIREMENTS:**

**Education and Training:**

A Bachelor's degree in Psychology, Social Work, Counseling or a related field. ***(to receive full credit for education, training and experience applicant must submit copies of transcripts, degrees, diplomas, certificate, etc.)***

**Experience:**

Two (02) years substance abuse counseling experience; or an equivalent combination of education, training, and experience which provides the capabilities to perform the described duties.

**Special Knowledge, Skills and Abilities:**

Knowledge of 12-step counseling process for substance abusers; resources in the community that can be tapped as needed; group facilitation techniques, principles and practices of psychology and counseling, effects of substance abuse over time. Skill in identifying the causes of substance abuse for the patient; developing an appropriate treatment plan for each patient; establishing and maintaining effective working relationships; developing community/chapter resources for the benefit of the patient and interacting with patients in a one-on-one and group situation.
