**DUTIES AND RESPONSIBILITIES:**

The Principal Attorney shall work under the general direction of the Attorney General and Deputy Attorney General and under direct supervision by the Assistant Attorney General of the Chapter Unit. The Principal Attorney is required to have excellent legal writing and legal research skills in order to provide legal guidance in writing to Chapter Officials, Chapter Staff, Administrative Service Center (ASC) Staff, and Division of Community Development (DCD) Staff. Such legal writings may also be required for other Navajo Nation elected officials and staff when issues surround Chapters and the Local Governance Act. The Principal Attorney may be assigned to attend governmental meetings such as Navajo Nation Council meetings, Standing Committee meetings, Chapter meetings, Agency Council meetings, and other meetings. Other duties may include drafting and/or reviewing contracts, legislations, Chapter policies, and other transactional documents submitted by or on behalf of Chapter governments. Other duties as assigned.
